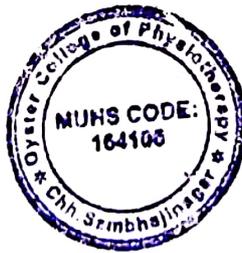

Clause 1

a) "Society" : Society shall mean "Student Academic Education Society" and the head office of the society shall be at Aurangabad.

b) "Person" : This shall mean and include an individual person. Institutions, Hind Undivided Families and Companies.

c) "Trustees" : Shall mean the trustee duly appointed the society.

"Trust Property" : Shall mean all the property of the society which the trustees will hold.

Clause 2

AREA OF OPERATION :- The complete State of Maharashtra.

Clause 3

FINANCIAL YEAR :-

The Financial year year which is and will be accepted by the Government of Maharashtra shall be the financial year of the society.

Clause 4

Any person, who agrees with the objects of the society and who is major and of sound mind and is other wise dis-qualified by law, and who has paid the membership fees can become a member of the society.

Powers and responsibilities of members :

Member of the society shall have following powers and responsibilities :-

- a) Member shall strive hard for the progress and stability of the society.
- b) The member shall deposit their membership fees regularly with the concerned persons of the society.
- c) Each members shall have right to put-forth his grievance as per the constitution and ask for the order upon such grievance.

Clause 5

Following shall be the types / classes of members.

- i) Patrons : Any person paying an amount of atleast Rs.500/ to the society shall become the patron member of the society.
- ii) Life Member : Any person paying an amount of atleast Rs.250/- to the society shall become the fellow member of the society.
- iii) Permanent Member : Any person paying an amount of atleast Rs.250 to the society shall become the permanent member of the society.
- iv) Follow member : Any person paying amount of atleast Rs.50 per year the society shall become the fellow member of the society.
- v) Honorary member : The society can bestow honorary membership to the person whom it decides had made an outstanding contribution in the field of education.

Clause 6

Termination of membership

The membership of a member shall be liable to be terminated in case the member fails and neglects to pay, for any one year his membership fees, within the prescribed period for payment of fees.

Clause 7

GENERAL BODY MEETING

- a) All member of the society shall constitute the general body.
- b) The general body establish the supreme authority of the society.
- c) The decisions taken by the General Body shall be final.
- e) Every year there shall be general body meeting.
- f) All the policy matters shall be discussed in the General Body Meeting
- g) In the annual General Body Meeting the account of the previous year and the financial budget for the forthcoming year should be discussed and shall need to be approved in the General Body Meeting.

GENERAL OF GENERAL BODY MEETING.

a) Before holding the General Body meeting, it will be necessary to issue notice of 21 days. The notice shall contain the day, date, time, venue and agenda of the general body meeting.

b) Quorum is 2/3 rd members having the right to vote or 30 whichever is less, shall form the Quorum. If the Quorum is not formed, the meeting shall be adjourned and

the member present shall form the Quorum.

c) The member who want to place suggestions or want to get some resolutions passed: they shall forward the same to the president before 8 days of the meeting.

d) If 10 members having voting right issues show cause notice to call for the general body: then in those circumstances, the general body will have to be called within one month from the date of such meeting and only those matters mentioned in such notice shall be disclosed in such General Body meeting.

e) The chairman and the President of the general body shall be the President of the Society and in his absence: the vice president shall be the chairman and if he is also not there, then the general body by majority shall appoint the President amongst them.

CLAUSE 8.

EXECUTIVE COMMITTEE :

The executive committee shall consist of 1 President, 1 Vice President, 1 Secretary, 1 Jt. Secretary, 1 Treasure and 7 members.

POWERS AND FUNCTIONS OF EXECUTIVE BOARD.

The powers, duties and the functions of Executive Board shall be as follows :-

a) To supervise and maintain the income expenditure account in the respect of the institutions run by the society before the general body.

b) To enroll the members of the society.

- c) To accept the money, deposits, borrow loans or in any manner raise the funds for the purpose of the working of the institutions and the society and to spend the money for the satisfactions of the objects of the society.
- e) To look into the complaints received from the members of the society and settle disputes if any.
- f) To prepare the yearly report and the budget and to put them before the General Body.
- g) To call for the General Body at least once in a year.
- h) To put before the General Body the working of the society the progress made by the society and the report of the income and expenditure and as well as the accounts.
- i) To frame the schemes and to take steps for fulfilling the objects of the society.
- j) To appoint the sub committees for achieving the objects of the society.

POWERS OF THE PRESIDENT AND VICE PRESIDENT.

President of Executive Council shall have following powers :-

- a) To call for the meetings of the Executive Council and the General body meeting. The notice for the meeting of Executive Council and the General Body shall be issued by the president only.

- b) To be the chairman of the Executive Council and the General body.
- c) To supervise and income and expenditures of the institutions run by the society.
- d) To spent maximum of Rs.500/- in its special authority in cases of emergency for the purpose of the society and institutions.
- e) To sanction leave to the employees of the society and the institutions for maximum period of 15 days.

POWERS AND RESPONSIBILITIES OF SECRETARY.

The secretary shall have following powers :

- a) To prepare the reports minutes of the meeting of the Executive Council's and General Body, and to implement the resolutions passed therein.
- b) To maintain the accounts i.e. Income and expenditure of the society.
- c) To prepare the annual report and to get the sanction from the Executive Council.
- d) To prepare the annual budget and to get the sanctions from the Executive Council.
- e) To maintain and handle correspondence with the persons connected with the society and also with concerned Government Departments and Officials.
- f) To prepare and maintain all the legal documents which are necessary as per the executive council.

d) To maintain separate registers of the donors to and members of the society.

In absence of secretary the joint secretary shall have all the powers and duties of the secretary.

POWERS AND RESPONSIBILITIES OF TREASURER.

Treasurer shall have following powers and responsibilities :-

a) To see that the amount which have been given has been spent for the object for which the same were given and to see that the amounts are spent as per annual budget.

b) to deposit in the bank the amounts as is reserved by the Executive council and to issue the necessary receipts.

c) To maintain the accounts of the society.

Clause 9

QUALIFICATION :

To be a member of executive council, the person who is continuous member of the society for continuous period of more than three year shall only be competent to be a member of executive council.

CLAUSE 10

VOTING POWERS : A person who is continuously member for more than 6 months prior to the elections of the executive council shall only have right to vote.

CLAUSE 11

VACANCIES

If any vacancy arises in the executive council for any reason such as death, resignations or if the said member is otherwise disqualified, then the remaining members of the executive council shall fill in the post/vacancy by majority and inform in the General Body meeting about such recruitment.

CLAUSE 12

MEETING OF THE EXECUTIVE COUNCIL :

a) The executive council shall holds it's meeting at least three times in a year.

b) the notice of the meeting shall be give 7 days in advances. In case of emergency. This rule of 7 days notice will not be applicable, the notice shall contain the date, place and time of the meeting as well as the Agenda for such meeting.

CLAUSE 13

QUORUM FOR THE MEETING OF EXECUTIVE COUNCIL :

Minimum 4 members shall constitute the quorum for the meeting of Executive council. If, there are less than 4 members then the President may adjourn the meeting. And on the adjourned time shall start the meeting. For the meeting to be held on the adjourn time the rule of quorum will not apply.

CLAUSE 15

EFFECT OF ABSENCE OF A MEMBER OF EXECUTIVE COUNCIL :

If any member of the executive council remains absent for three consecutive meeting of the executive council then in such circumstances the said member who has remained absent for three consecutive Executive council meeting shall cease to be the members of the Executive council.

CLAUSE 16

FUNDS AND PROPERTY :

Funds for the society will be collected through the membership fees of the ordinary members and associate members and donations made available for the cause of charity society's working. The society may conduct certain charity shows to raise funds.

Clause 17

DEPOSITS AND LOANS :

The society will not take any load from any person for its day to day working in normal circumstances, in the event acute need members meeting. It may go for a long terms load from the any Government of private institution in the case of construction of the school project or any heavy expenses for the same prior permission of the Joint Charity Commissioner will be obtained.

PURCHASE AND SALE OF THE PROPERTY :

All the decisions about sale or purchase of any property by the society will be taken in the General Body Meeting with atleast 2/3rd of the members supporting it.

Clause 19

BANK ACCOUNT/S.

The society proposes to open bank accounts in any of the bank/s which the charity commissioner or any equivalent authority will approve, in the name of the society and in any nationalised Bank.

BANK TRANSACTIONS

All the transactions will be made by cheque which are signed by atleast two of the following.

i) The President ii) The Vice-President and iii) The Treasurer. through a joint. All the accounts will be verified at the end of every financial year by a Chartered Accountant.

MEMBERS REGISTER :

Members register will be maintained in Schedule VI of the rules under Sanghas Registration Act, 1860.

Clause 21

AMENDMENTS IN THE CONSTITUTION

The constitution can be amended in the general body meeting by not less than 2/2rd members present in the said General Body Meeting.

Clause 22

ELECTION :

The election of the Executive council shall be held every seven years in the General Body meeting. The Executive council shall appoint the Returning officer and the executive council shall have powers to form the elections committee for the purpose of holding the elections for the members and office bearers of the executive council.

The election committee appointed shall frame the election programme and the chairman of the election committee who shall also be returning officer shall declare the elected officer and the members of new executive council.

Clause 23

TERM OF THE MEMBERS OF EXECUTIVE COUNCIL.

The executive council shall be for seven years. New executive council shall be constituted after the period of seven years.

The members who were the members of the Executive Council and all the office bearers of the executive council shall, have a right of re-election.

Clause 24

MERGER OR DISSOLUTION OF THE SOCIETY :-

The society can be merged in any such organisation working in the field of education as a charitable organisation. The decision regarding dissolution of the society vests in the Executive Council and for that matter a resolution shall be needed with a 2/3 majority

(Dictated and delivered on 08.08.2011).

1. This is an application u/s 22 of the Bombay Public Trusts Act, 1950 (for short 'the Act') in respect of change has arisen due to election and resignation of one of the namely V.T. Suryavanshi.

Briefly stated facts are "Students Academic Education Society, Aurangabad, Dist. Aurangabad" is a public trust registered at P.T.R. No.F-5512 (Aurangabad) (for short 'the trust'). By notice dated 11.11.2010 (Exh. 2) meeting of special general body was convened on 05.12.2010 with the agenda to accept resignation of one of the trust and to conduct an election and accordingly it was circulated amongst all the members wherein as per minutes of proceeding dated

(1) Manpreetsing Johar, President, (2) Jaswantsing Johar Vice President, (3) Chandok Jagjeet Kaur, Treasurer, (4) Ramu Margaret, Secretary, (5) Preetikaur Kanda, Member, (6) Sukhminkaur Kohali, Member and (7) Dr. Mayur Goklani, Member. Hence on 20.12.2010 present change report has been filed alongwith copy of Schedule-I. (Exh. 4), consent letter (Exh. 5) of new trustee Dr. Mayur Goklani, resignation letter (Exh. 6) of outgoing trustee V.T. Suryavanshi, certified copy of memorandum of association (Exh. 16) and copy of Schedule-C (Exh. 17).

3. Since there were no outgoing trustees, issue of notice has been dispensed with. Besides this, all existing trustees including outgoing trustee V.T. Suryavanshi have given consent to the present change report vide pursis (Exh. 10) filed by Adv. Kishore D. Nade.

4. In support of the present change report applicant Manpreetsing Johar (AW-1: Exh.13) has examined himself on oath.

5. On the basis of above stand; consent of incoming trustees, no objection of outgoing trustee, the documents and

evidence points for determination along with findings for the reasons are discussed hereunder.

POINTS

1. *Whether the change reported in the entries recorded in the register is legal and valid?*
2. *What order?*

FINDINGS

REASONS

6. Point No. 1 : Manpreetsing Johar (AW-1: Exh.13) has testified in consonance with above stand. Notice dated 11.11.2010 (Exh. 7) and minutes of proceeding dated 05.12.2010 (Exh. 8) also evidences the above fact. Thus the testimony of applicant (AW-1) is corroborated by documentary evidence, therefore it inspires confidence.

7. Now it is necessary to advert to the Constitution of the trust. It reveals that any change by way of election in the trust is to be effected by majority decision of general body. In the light of the above discussion, above change has been effected as per the Constitution of the trust. Hence it is valid.

8. It is useful to quote section 22 of the Act. It reads as under:

S.22 (1) where any change occurs in any of the entries recorded in the register kept

u/s 17, the trustee shall, within 90 days from the date of occurrence of such change report such change to the deputy or assistant charity commissioner in charge of the Public Trust Registration Office where the register is kept. Such report shall be made in prescribed form.

It is evident that above provision has been fully complied with.

9. To sum up in the light of the above discussion applicant has proved that reported change is legal and valid. Hence finding to above point is recorded in affirmative.

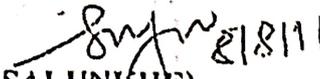
10. Point No.2: In the light of above discussion this change report deserves to be accepted. Hence to record finding to this point following order is passed.
